

**Notification pursuant to Art. 5 (1) lit. b) of Regulation (EU)
No. 596/2014 and Art. 2 (3) of Delegated Regulation (EU)
No. 2016/1052**

Frankfurt am Main, 6 May 2024. In the period from 29 April 2024 up to including 3 May 2024, Deutsche Beteiligungs AG acquired a total of 11,411 shares as part of its ongoing share buyback program, which was announced in the notification of 4 March 2024 in accordance with Art. 5 (1) lit. a) of Regulation (EU) No. 596/2014 and Art. 2 (1) of Delegated Regulation (EU) No. 2016/1052.
